Dear City of Trotwood Taxpayer:

Through an agreement with the City of Trotwood and the U.S. Department of Treasury, Internal Revenue Service, as authorized by Internal Revenue Code Section 6103(d), the Central Collection Agency obtained information that you have received income which may be subject to the City of Trotwood income tax. Please provide this information to this office in the envelope enclosed. **NOTE:** Only the Central Collection Agency has access to the U.S. Department of Treasury, Internal Revenue Service information. The City of Trotwood does not have access to the IRS information and is unable to assist you with questions.
